Sensus Regulatory Update

Re: EU Regulation 1169/2011 on provision of food information to consumers

To whom it may concern,

One of the areas covered by this Regulation includes nutrition information. A nutrition declaration specified by the Regulation shall become mandatory. This section of the Regulation shall apply from 13 December 2016; as a transitional measure foods placed on the market or labelled prior to 13 December 2016 which do not comply with the Regulation may be marketed until the stocks of food are exhausted.

The nutritional information on the product data sheets for Frutafit® and Frutalose® have been modified accordance with the Regulation:

- New order of presentation for nutritional information
- Energy value (kJ/kcal) provided per 100 grams
- Modified definition of carbohydrates; “*carbohydrates means any carbohydrate which is metabolized by humans and include polyols*”
- On the nutrition declaration: ‘*carbohydrates (sugars, polyols, starch)*’
 - ‘*sugars*’ means all monosaccharides and disaccharides present in food. Effect: average +2 g of sugars is included per 100 g Frutalose® products due to the disaccharides (F-F)
- Definition of fibre: “*‘fibre’ means carbohydrate polymers with three or more monomeric units, which are neither digested nor absorbed in the human small intestine and belong to the following categories:*
 - *edible carbohydrate polymers naturally occurring in the food as consumed,*
 - *edible carbohydrate polymers which have been obtained from food raw material by physical, enzymatic or chemical means and which have a beneficial physiological effect demonstrated by generally accepted scientific evidence,.....*” Regulation No 1169 / 2011, Annex I
- On the nutrition declaration, inulin present in Frutafit® and Frutalose® should be declared as ‘*fibre*’
